**RE: concerns of Davoud Tohidy regarding geo-engineering chemtrails**

I represent Davoud Tohidy, who is a concerned Canadian citizen living in [REDACTED]. He has asked me to write to each of you regarding his concerns about Stratospheric Aerosol Geoengineering, commonly known as chemtrails. *This aerial spraying is being carried out without the knowledge or consent of the People of Canada.*

*All citizens have the inalienable right not to be sprayed from the sky in this manner for whatever purpose that such activity may be.*

*You, as an authority responsible for public health and safety of Canadian Citizens as well as protecting our great country Canada, have the legal obligation to protect Canadians from being exposed to unhealthful substances.*

*Therefore I would like to request from you to please order to conduct several full investigations in this matter and take all the measures needed to stop this illegal activity immediately.*

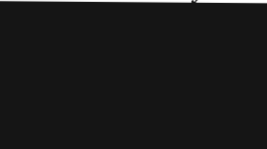
